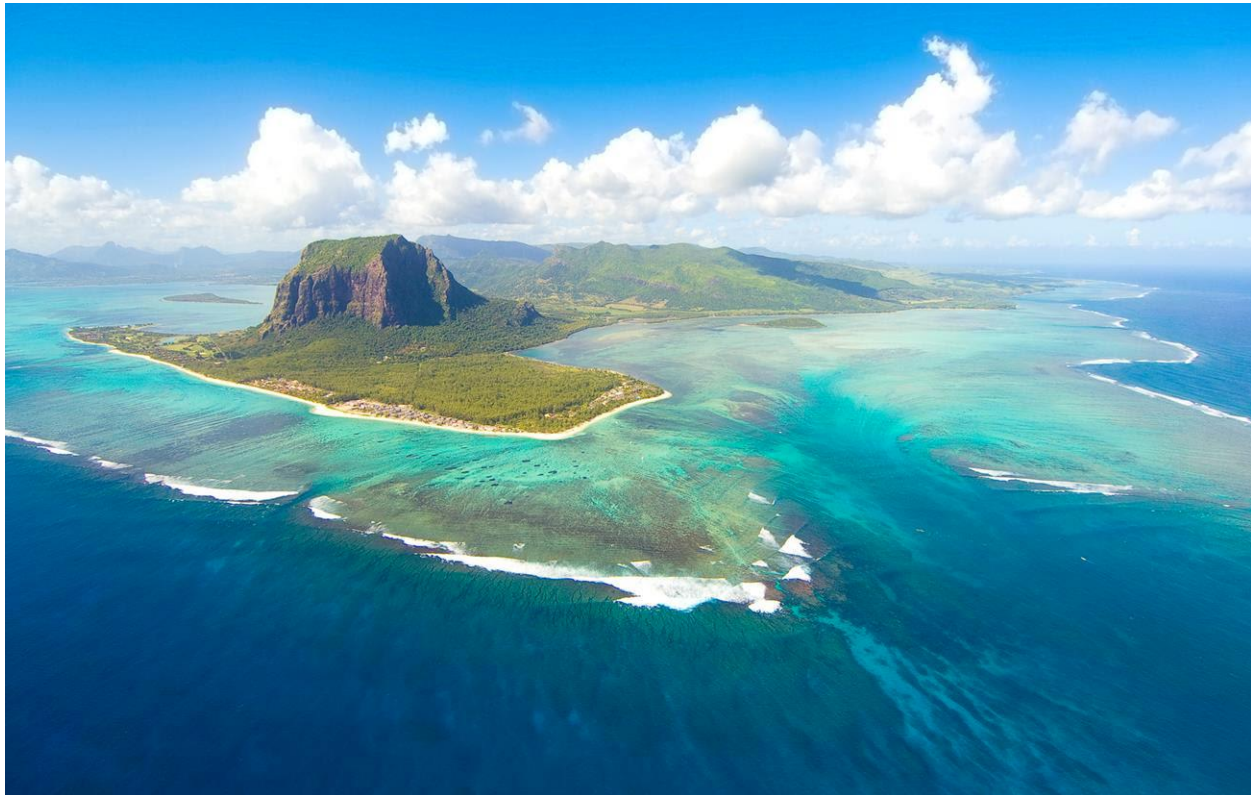


MAURITIUS ARBITRATION WEEK
